CAT NMS Plan, Exemptive Relief and Transaction Interpretive Updates

Transaction Interpretive Updates

New and Updated FAQs

- ► No new Transaction <u>FAQ</u>s.
- One Transaction <u>FAQ</u> was updated.
 - FAQ <u>D10</u> was updated to clarify that full cancellation of a "cash" order must be reported using an Order Cancelled event with a *cancelQty* of '0' and *leavesQty* of '0'.

Technical Specification Updates

There were no updates to the Transaction Technical Specifications or Reporting Scenarios document.

Metadata File Reminder

- For submissions to the Transaction database, effective July 24, 2023, the Metadata File submission associated with the Data File will no longer be supported.
 - If a Metadata file is submitted on or after July 24, 2023, it will be rejected at the File Acknowledgement stage of processing.
- This was discussed during the April 18, 2023 <u>Technical Specifications</u> <u>Working Group</u>.

*Per FAQ Q67, effective July 12, 2023, each Customer must be reported to CAIS with at least one address.
